The **Riverside County Professional Firefighters Benevolent Fund** is proud to assist those making the choice to receive body scans. Our local benevolent fund has committed \$10,000.00 in reimbursements to CAL FIRE Riverside Professional Firefighters that complete an exam and apply for reimbursement directly through the benevolent fund. Reimbursement will be on a first come basis, the program may be renewed and or cancelled without notice if funds become unavailable. Union affiliation is not a requirement of reimbursement, but union status will be collected for future data evaluations. Funds will be reimbursed on a sliding scale that is determined by the benevolent fund. Years of service will be determined by your state service with CAL FIRE and or affiliated departments within Riverside County that CAL FIRE has absorbed. Reimbursement may be requested from the RCPFBF on a case by case basis for other years of service. Reimbursement is restricted to CAL FIRE Riverside Professional Firefighters, but others may apply and receive reimbursement by petitioning the RCPFBF Board of Directors in writing. Those receiving reimbursement from Attorney Larry Whiting or any other attorney and or source are not eligible for reimbursement. While Superior Body Scan has been recommended as a vendor other reputable and approved vendors will be acknowledged by the RCPFBF. A copy of your receipt must be attached to this application to qualify for reimbursement. Reimbursement cannot be completed prior to the exam date. Please allow 3-4 weeks for reimbursement. Forms and supporting documentation must be mailed to the RCPFBF.
